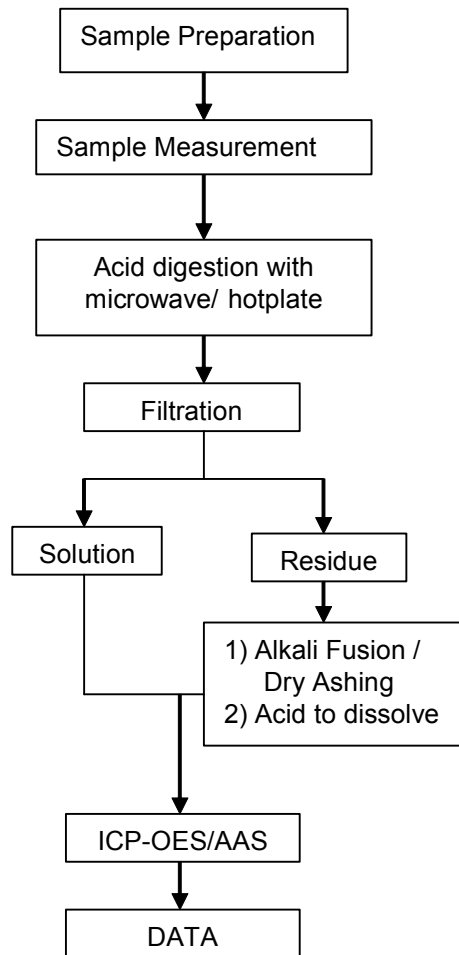

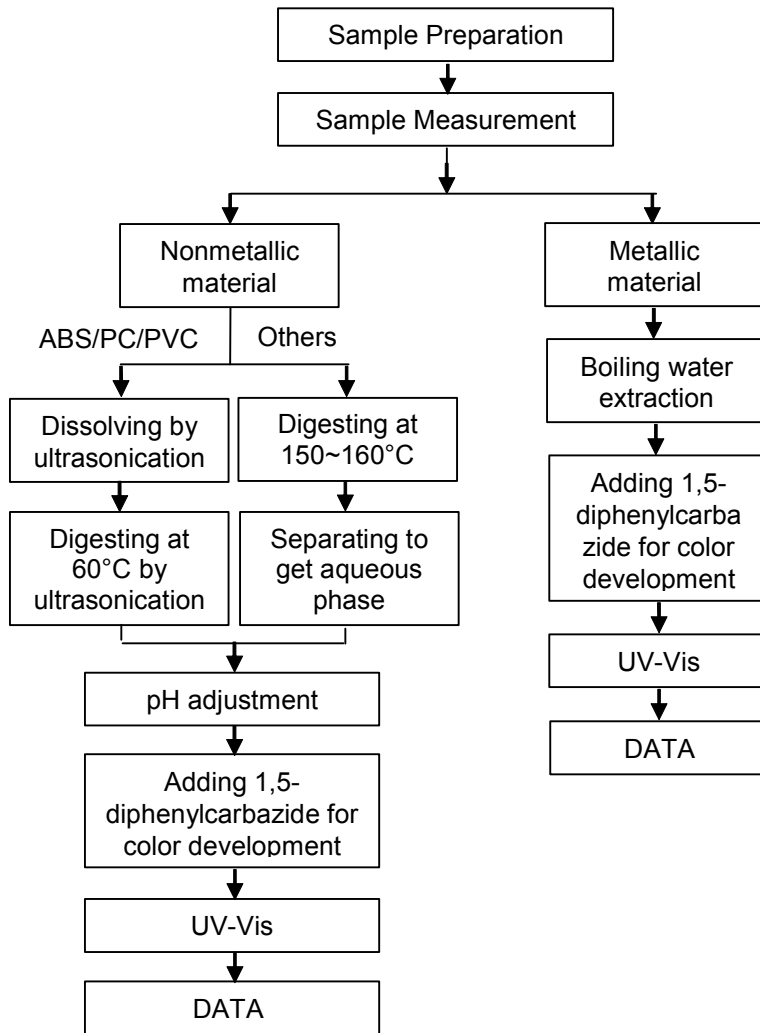
Pb / Cd / Hg Testing Flow Chart

1) These samples were dissolved totally by pre-conditioning method according to below flow chart.

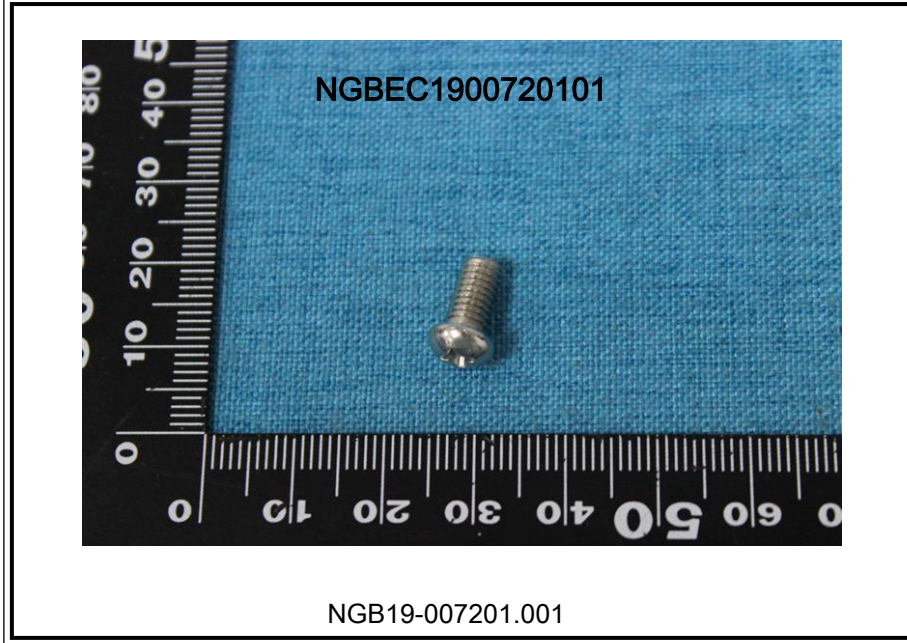
